Core Hours

The purpose of this agreement is to reduce the default core hours from 10am to 2pm to 9 am to 11am in accordance with the Master Agreement, Article 18, number 5, paragraphs b and c

The default core hours for employees on Maxiflex schedules will be the 3 middle days of the employees' regularly scheduled administrative workweek from 9am to 11am.

The default core hours for employees on Variable Day and Variable Week schedules will be each day of the employees' regularly scheduled administrative workweek from 9am to 11am.

Deviations from these hours and or days are allowable on an occasional basis with supervisor approval.

This agreement shall be reviewed in conjunction with a general review of agreements done at the time of expiration of the current Master Agreement between the Forest Service and the National Federation of Federal Employees. This agreement shall remain in effect until a new agreement is reached to modify its terms or the parties mutually agree to terminate the agreement.
